

## CONSENT FOR PROCESSING OF PERSONAL DATA

By signing this form, \_\_\_\_\_ (the “**Data Subject**”) provides consent (the “**Consent**”) to SKANESTAS INVESTMENTS LIMITED, Reg. No HE 322788 of the Republic of Cyprus, registered at Arch. Makariou III, 226, 3030 Limassol, Cyprus (the “**Company**”), to process his/her personal data in accordance with the following terms and conditions:

1. The Consent hereof is given for personal data processing.
2. The Consent hereof is given for processing the personal data, which include but not limited to: surname, name, middle name, place of work and position held, contact information (e-mail addresses, contact telephone numbers, work address, home address), date and place of birth, citizenship, sex, marital status, details on income, information contained in personal identification documents (including passport details), tax number, tax residency, details of the profession.
3. Personal data is not made publicly available.
4. Purpose of personal data processing (to be clearly identified): legal obligations in accordance with the DIRECTIVE (EU) 2015/849 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on the prevention of the use of the financial system for the purposes of money laundering or terrorist financing, Directive for the Prevention of Money Laundering and Terrorist of the CYPRUS SECURITIES AND EXCHANGE COMMISSION, Common Reporting Standard (CRS) approved by OECD Council and other relevant provisions of the law, contractual obligations.
5. Consent for processing of personal data is required on the basis: Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (General Data Protection Regulation-GDPR).
6. Personal data processing may involve the following procedures: collection, recording, systematization, accumulation, storage, modification (updating, revision), retrieval, use, deletion, destruction, blocking, transfer (dissemination, provision, and access), cross-border transfer.
7. The transfer of personal data to third parties is carried out on the basis of the legislation of the Republic of Cyprus, a contract involving the Data Subject or the Consent of the Data Subject.
8. Personal data may be entrusted to third parties for processing, including custodians, sub-custodians, internal auditor, external auditor or persons identified in clause 13.
9. Personal data is processed by the Company until the purposes specified in the present Consent are achieved or until the withdrawal of this Consent by the Data Subject or his/her representative is received or until agreement between the Data Subject and the Company is terminated in accordance to its conditions, whichever comes first.

- 10.** The Data Subject or his/her representative may withdraw this Consent for processing of personal data by sending an appropriate notice in a free form to the Data Protection Officer of the Company (DPO) [dpo@skanestas.com](mailto:dpo@skanestas.com) or by sending a corresponding letter in a simple written form to the following address: Arch. Makariou III, 226, first floor, 3030 Limassol, Cyprus.
- 11.** If the Data Subject or his/her representative withdraws Consent for processing of personal data, the Company may continue to process such personal data without such Consent on the grounds stipulated in the applicable law provisions.
- 12.** This Consent shall be valid until the processing of the personal data is discontinued as indicated in clauses 9 and 10 of the present Consent.
- 13.** The Data Subject confirms that he/she received the following information from the Company:
- (a) the identity and the contact details of the Company;
  - (b) the contact details of the Data Protection Officer;
  - (c) the purposes of the processing for which the personal data are intended as well as the legal basis for the processing as identified in clauses 3-4 of this Consent;
  - (d) where the processing is based on point (f) of Article 6(1) of GDPR, the legitimate interests pursued by the controller or by a third party;
  - (e) the recipients or categories of recipients of the personal data:
    - Supervisory and other regulatory and public authorities, inasmuch as a statutory obligation exists (Cyprus Securities and Exchange Commission, the income tax authorities, social insurance authorities, etc.);
    - Other investment firms, management companies and depositaries, such as Custodians, Depositaries, Exchanges;
    - According to our procedures for combating money laundering and financing of terrorism, the entities that provide information on regulatory compliance;
    - External legal consultants;
    - Auditors and accountants;
    - File storage companies, archiving and/or records management companies;
    - Companies that developed the Company's systems, companies who assist us with the effective provision of our services to you by offering technological expertise, solutions and support and facilitating trading.
  - (f) where applicable, the fact that the Company intends to transfer personal data to a third country or international organisation or in the case of transfers referred to in Article 46 or 47, or the second subparagraph of Article 49 (1) of GDPR, reference to the appropriate or suitable safeguards and the means by which to obtain a copy of them or where they have been made available;
  - (g) the right of Data Subject to lodge a complaint with a supervisory authority;
